

FAMILIARISATION PROGRAMME FOR INDEPENDENT DIRECTORS

(In terms of Regulation 25 of SEBI (LODR) Regulations 2015)

- 1. Nucleus Software Exports Ltd. (the Company) has constituted various familiarization programmes for its Directors (Independent and Non-Independent), with an objective to :**

- 2. The familiarization programmes comprise of a combination of written information, presentations and activities, including meetings and site visits and are based on the following:**
 - a) In-house training and updates by the Company officials is provided to the Directors about all business matters including Finance, Marketing, HR, Product Management, Risk Assessment & Mitigation and New Strategies through presentations and written documents at the meetings or through website/emails.
 - b) The Company also engages specialists in various areas/domains to provide information on topics of interest.
 - c) The Company also looks for training programs/conferences/seminars/workshops etc. organized by external agencies and reputed institutions on such subjects, which would enable Directors to update their knowledge base. The Company Secretary informs all the Directors about such training programs and facilitates the attendance of the interested Directors. At the same time, the Directors may also self- nominate themselves for any such training program.
 - d) For Independent Directors, the Company conducts/ provides lectures/materials/documents to cover topics of relevance.
 - e) The Company also has a web based secured information portal, with access only to Directors, where they can log in and get all Board and its meetings/committee meetings required data and information besides regulatory and other industry updates.
